A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO AUTHORIZING THE FIRST AMENDMENT TO THE AGREEMENT WITH JANUS CORPORATION FOR ASNEEDED ASBESTOS, LEAD AND MOLD ABATEMENT SERVICES AT CITY FACILITIES AND TAKING RELATED ACTIONS.

WHEREAS, the City of San Diego (City) requires the specialty services of a certified abatement contractor to carry out as-needed asbestos, lead and mold abatement work in City facilities; and

WHEREAS, the City entered into an agreement with Janus Corporation on September 3, 2020, through the Invitation to Bid Number 10089664-20-B competitive solicitation process to provide as-needed asbestos, lead and mold abatement services at City facilities (Contract); and

WHEREAS, the initial term of the Contract was for a five-year period in an amount not to exceed \$2,996,125, and therefore below the threshold amount requiring Council of the City of San Diego (Council) approval; and

WHEREAS, this First Amendment to the Contract seeks to add \$1,503,875 to the contract value, increasing the not to exceed amount from \$2,996,125 to \$4,500,000 and requiring Council approval per San Diego Municipal Code section 22.3206(e); and

WHEREAS, City staff has identified large-scale projects that will be performed before the end of the Contract term, including several roof abatement and lead abatement projects, and regulatory required abatement of eight vacant buildings prior to demolition preceding construction of the City's Pure Water Project; and

WHEREAS, this authorization will ensure that the Contract will have additional, necessary capacity to complete these and other needed abatement services during the remainder of the five-year Contract term; and

WHEREAS, the Office of the City Attorney has drafted this resolution based on the

information provided by City staff, with the understanding that this information is complete, true,

and accurate; NOW, THEREFORE.

BE IT RESOLVED, by the Council of the City of San Diego, that the Mayor, or his

designee, is authorized to execute the First Amendment to the Agreement between the City of

San Diego and Janus Corporation for as-needed asbestos, lead and mold abatement services at

City facilities increasing the not to exceed amount from \$2,996,125 to \$4,500,000 contingent

upon the Chief Financial Officer first furnishing one or more certificates certifying that funds

necessary for expenditure are, or will be, on deposit with the City Treasurer.

BE IT FURTHER RESOLVED, by the Council of the City of San Diego, that the Chief

Financial Officer, or his designee, is authorized to expend an amount not to exceed \$4,500,000 in

total, over the remaining contract term from the General Fund, Capital Improvements Program

funds, or Enterprise funds, including but not limited to, an amount not to exceed \$1,476,712

from the Public Utilities Department, Water Utility Operating Fund 700011, for the purpose of

funding the First Amendment to the Agreement between the City of San Diego and Janus

Corporation for as-needed asbestos, lead and mold abatement services at City facilities,

contingent upon adoption of the Annual Appropriation Ordinance for the applicable fiscal year.
