A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO AUTHORIZING THE ADDITION OF A STANDALONE PROJECT TO THE CAPITAL IMPROVEMENTS PROGRAM, AN INCREASE TO THE CIP BUDGET IN CIP S-24008, SD EAST OF RACHAEL AVENUE SWD, AND APPROPRIATION AND EXPENDITURE FROM FUNDS 400881 AND 400884.

WHEREAS, the SD East of Rachael Ave SWD project area is located in the Skyline-Paradise Hills Community Plan Area in Council District 4 and the project boundary is Gables Street to the North, Rachael Avenue to the West, Cumberland Street to the South, and Sea Breeze Drive to the East; and

WHEREAS, the project area experiences frequent flooding due to an inadequate and aged stormwater drainage system; and

WHEREAS, the SD East of Rachael Ave SWD project (project) will alleviate flooding and erosion problems through the replacement, abandonment, upgrade, and realignment to the right of way of existing Corrugated Metal Pipes, installation of new reinforced concrete pipes, and inlets and cleanouts to ensure the installed pipe systems properly convey stormwater flow and can be properly maintained; and

WHEREAS, the requested appropriations will fund preliminary design and planning activities for future implementation of the project; and

WHEREAS, it is necessary to create a standalone project within the Capital Improvements Program (CIP) and authorize the increase to the CIP Budget in CIP S-24008, SD East of Rachael Ave SWD, and to appropriate and expend \$2,748,800.00 of which \$549,760 is from Fund 400881, Debt Funded General Fund CIP, and \$2,199,040 is from

Fund 400884, General Fund WIFIA Loan-Construction, to fund preliminary design and planning activities for the project;

WHEREAS, the Office of the City Attorney has drafted this resolution based on the information provided by City staff, with the understanding that this information is complete, true, and accurate; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego that the Chief Financial Officer is authorized to add CIP S-24008, SD East of Rachael Ave SWD, to the Capital Improvements Program;

BE IT FURTHER RESOLVED, that the Chief Financial Officer is authorized to increase the CIP Budget in CIP S-24008, SD East of Rachael Ave SWD, and to appropriate and expend \$549,760 from Fund 400881, Debt Funded General Fund CIP, and \$2,199,040 from Fund 400884, General Fund WIFIA Loan-Construction, for a total not to exceed \$2,748,800 to fund preliminary design and planning activities for the SD East of Rachael Ave SWD project.
