A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO AUTHORIZING THE ADDITION OF A PRELIMINARY ENGINEERING CAPITAL IMPROVEMENT PROJECT TO THE CAPITAL IMPROVEMENTS PROGRAM, AN INCREASE TO THE CIP BUDGET IN CIP P-24010, STORMWATER CIP PROGRAM MANAGEMENT, AND TRANSFER OF APPROPRIATIONS OF \$8,500,000 FROM FUND 400884, GENERAL FUND WIFIA LOAN-CONSTRUCTION.

WHEREAS, on April 5, 2022, the Council of the City of San Diego (Council) adopted

Ordinance O-21445 authorizing a Lease Arrangement for a principal amount not to exceed \$359.2

million through the Environmental Protection Agency (EPA) under the Water Infrastructure

Finance and Innovation Act (WIFIA) to finance a portion of the Stormwater Capital Improvement

program and authorizing Credit Facility documents and leases thereunder; and

WHEREAS, on August 9, 2022, the City executed a WIFIA Master and Credit loan agreement (WIFIA loan agreement), with the EPA to fund critical Stormwater Department (SWD) infrastructure needs through capital improvement projects (CIP) in the Capital Improvements Program; and

WHEREAS, on December 6, 2022, the Council adopted Resolution R-314484 authorizing an agreement with HDR Engineering, Inc. for program management and engineering design services for the WIFIA loan funded CIP (Contract H2226019); and

WHEREAS, pursuant to Contract H2226019, HDR Engineering, Inc. (HDR) will, over the course of the WIFIA loan agreement: maintain a Program Management Office (PMO), uphold CIP program controls, develop CIP schedules, establish processes and procedures, collaboratively oversee and manage the work to be performed under the program including coordination with the SWD and other City Departments, and monitor the progress and reporting of WIFIA funded

activities to the EPA; and

WHEREAS, it is necessary to add this preliminary engineering capital improvement project to the Capital Improvements Program, to authorize an increase to the budget in CIP P-24010, Stormwater CIP Program Management, and to transfer appropriations not to exceed \$8,500,000 from Fund 400884, General Fund WIFIA Loan-Construction, to fund HDR's PMO programmatic activities; and

WHEREAS, the Office of the City Attorney has drafted this resolution based on the information provided by City staff, with the understanding that this information is complete, true, and accurate; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego that the Chief Financial Officer is authorized to add CIP P-24010, Stormwater CIP Program Management, to the Capital Improvements Program;

BE IT FURTHER RESOLVED, that the Chief Financial Officer is authorized to increase the Capital Improvements Program Budget in CIP P-24010, Stormwater CIP Program Management, and to transfer appropriations in an amount not to exceed \$8,500,000 from Fund 400884, General Fund WIFIA Loan-Construction, for the purpose of funding HDR Engineering, Inc. programmatic activities.
