A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO APPROVING A SIDE LETTER AGREEMENT BETWEEN THE CITY AND THE SAN DIEGO MUNICIPAL EMPLOYEES ASSOCIATION TO AMEND ARTICLE 21 OF THE MEMORANDUM OF UNDERSTANDING RELATED TO LIBRARY SPECIAL ASSIGNMENT PAY AND NOTARY PAY.

WHEREAS, by San Diego Resolution R-314970 (June 12, 2023), the San Diego City Council (Council) approved a Memorandum of Understanding (MOU) between the City of San Diego (City) and the San Diego Municipal Employees Association (MEA) that establishes terms and conditions of employment for MEA-represented employees; and

WHEREAS, Article 21, section C(14) of the MOU provides special assignment pay to all classifications under the Librarian and Librarian Assistant series who are assigned to work on Sundays (Library Special Assignment Pay); and

WHEREAS, Article 21, section C(18) of the MOU provides special assignment pay to all employees in any classification who are authorized by the City to obtain and maintain a Notary Public Commission from the California Secretary of State and use that certification in furtherance of the City's business (Notary Pay); and

WHEREAS, the City and MEA reached a tentative agreement to amend Article 21, sections C(14) and C(18) to clarify the terms for being eligible to receive either special assignment pay as provided in the Side Letter Agreement (Agreement) on file in the Office of the City Clerk as Document No. RR-315156 and

WHEREAS, the Agreement must be approved by a two-thirds majority vote of the Council to take effect, in accordance with San Diego Charter section 11.2; and

WHEREAS, the Office of the City Attorney has drafted this resolution based on the information provided by City staff, with the understanding that this information is complete, true, and accurate; NOW, THEREFORE,

BE IT RESOLVED, by the City Council of the City of San Diego, that the Council approves the Agreement between the City and MEA to amend Article 21, sections C(14) and C(18) of the MOU related to Library Special Assignment Pay and Notary Pay, which is on file in the Office of the City Clerk as Document No. RR-\_\_315156\_.
