A RESOLUTION OF THE COUNCIL OF THE CITY OF
SAN DIEGO APPROVING A SIDE LETTER AGREEMENT
BETWEEN THE CITY AND THE AMERICAN FEDERATION
OF STATE, COUNTY AND MUNICIPAL EMPLOYEES,
AFL-CIO, LOCAL 127 TO AMEND ARTICLE 14 OF THE
MEMORANDUM OF UNDERSTANDING RELATED TO
SPECIAL ASSIGNMENT PAY FOR STREET LIGHTING
ELECTRICIANS AND TRAFFIC SIGNAL TECHNICIANS.

WHEREAS, by San Diego Resolution R-314969 (June 12, 2023), the San Diego City Council (Council) approved a Memorandum of Understanding (MOU) between the City of San Diego (City) and the American Federation of State, County and Municipal Employees, AFL-CIO, Local 127 (Local 127) that establishes terms and conditions of employment for Local 127-represented employees; and

WHEREAS, Street Lighting Electricians and Traffic Signal Technicians are responsible for installing, repairing, modifying, testing, and maintaining various electrical assets of the Transportation Department; and

WHEREAS, Article 14, section B(8) of the MOU provides special assignment pay to Electricians and Plant Process Control Electricians who hold a state electrician certification; and

WHEREAS, to support Street Lighting Electricians and Traffic Signal Technicians to perform their tasks efficiently and provide improved public services, the City and Local 127 reached a tentative agreement to amend Article 14, section B(8) and extend the special assignment pay to Street Lighting Electricians Traffic Signal Technicians who maintain a Licensed General Electrician Certification issued by the State of California; and

WHEREAS, the terms of the tentative agreement are provided in the Side Letter Agreement (Agreement) on file in the Office of the City Clerk as Document No. RR-**315157** and


WHEREAS, if approved, the amendment to Article 14, section B(8) will be retroactive to July 1, 2023; and

WHEREAS, the Agreement must be approved by a two-thirds majority vote of the Council to take effect, in accordance with San Diego Charter section 11.2; and

WHEREAS, the Office of the City Attorney has drafted this resolution based on the information provided by City staff, with the understanding that this information is complete, true, and accurate; NOW, THEREFORE,

BE IT RESOLVED, by the City Council of the City of San Diego, that the Council approves the Agreement between the City and Local 127 to amend Article 14, section B(8) and of the MOU related to special assignment pay for Street Lighting Electricians and Traffic Signal Technicians, which is on file in the Office of the City Clerk as Document No. RR-**315157**.




