A RESOLUTION OF THE COUNCIL OF THE CITY OF
SAN DIEGO TO AUTHORIZE THE MAYOR OR DESIGNEE
TO ACCEPT, APPROPRIATE AND EXPEND FUNDING
FROM THE CALIFORNIA BOARD OF STATE AND
COMMUNITY CORRECTIONS FOR THE SAN DIEGO
POLICE DEPARTMENT OFFICER WELLNESS AND
MENTAL HEALTH PROGRAM.

WHEREAS, the San Diego Police Department (SDPD) has been awarded \$1,263,047 by
the California Board of State and Community Corrections (BSCC) to increase and supplement
the services offered in the SDPD Officer Wellness Program; and

WHEREAS, the SDPD Officer Wellness Program offers 24/7 assistance to SDPD
officers, civilians and retired employees and their families on topics such as building resiliency,
emotional wellbeing, alcohol and substance abuse intervention, mental health services, peer
support and more; and

WHEREAS, the SDPD Wellness unit has identified several projects to achieve these
funding objectives, including but not limited to upgrading exercise equipment at substations,
providing more access to licensed mental health professionals, and providing additional
psychological services; and

WHEREAS, these projects must be completed, and a report submitted to the BSCC, by
December 2025; and

WHEREAS, the Office of the City Attorney has drafted this resolution based on the
information provided by City staff, with the understanding that this information is complete, true,
and accurate; NOW, THEREFORE,


BE IT RESOLVED, by the City Council of the City of San Diego, that the Mayor or his designee is authorized, for and on behalf of the City, to accept \$1,263,047 and any additional funding authorized by the BSCC, through December 2025, for the purposes of supplementing the services provided by the SDPD Officer Wellness Program.

BE IT FURTHER RESOLVED, that the Mayor, or his designee is authorized, for and on behalf of the City, to enter into all agreements and certifications which relate to the funds authorized by the BSCC for the purposes of supplementing the services provided by the SDPD Officer Wellness Program.

BE IT FURTHER RESOLVED, that the Chief Financial Officer is authorized to accept, appropriate and expend \$1,263,047 and any additional funding authorized by the BSCC, through December 2025, for the purposes of supplementing the services provided by the SDPD Officer Wellness Program.

BE IT FURTHER RESOLVED, that the Chief Financial Officer is authorized to establish an account for the funding received by the BSCC, if required.


