WHEREAS, the City and AG-PCPI SKY PARK OWNER, L.P., a Delaware limited partnership (Landlord), negotiated a proposed Office Lease for the City to lease the Premises (Lease) for a term of seven years (Initial Term), with a City option to extend the Lease term for an additional three years; and

WHEREAS, the Office of the City Attorney has drafted this Resolution based on the information provided by City staff (including information provided by affected third parties and verified by City staff), with the understanding that this information is complete, true, and accurate; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego (Council), as follows:

- 1. The Council approves the Lease, including all attachments and exhibits to the Lease.
- 2. The Mayor or designee is authorized, on behalf of the City, to sign and enter into the Lease, including all attachments and exhibits to the Lease requiring the City's signature, and take all other actions reasonably necessary to perform the City's obligations under the Lease. A copy

\$4,269,019.73 in base rent, and an amount not to exceed \$1,201,663.00 in operating expenses

over the Initial Term of the Lease, from General Fund #100000, Cost Center #9912001112;

provided, however, that funding for base rent and operating expenses under the Lease in future

fiscal years after fiscal year 2024 is contingent upon the Council's annual appropriation of funds

for these expenses for each applicable fiscal year and the Chief Financial Officer furnishing one

or more certificates certifying that funds necessary for these expenditures, are, or will be, on

deposit with the City Treasurer.
