A RESOLUTION OF THE COUNCIL OF THE CITY OF
SAN DIEGO APPROVING THE SETTLEMENT BETWEEN
DEOVANTE GUY, ET AL. AND THE CITY OF SAN DIEGO,
ET AL.

WHEREAS, on August 17, 2020, Deovante Guy, by and through his Guardian ad Litem, Quintasia Walker, filed a suit against the City of San Diego for the injuries that occurred to Deovante Guy on February 28, 2019. The suit is entitled *Deovante L. Guy, et al. v. Matthew Lorenzen, et al.*, United States District Court Case No. 3:20cv2027 BAS-BLM (Litigation); and

WHEREAS, in closed session on September 11, 2023, the San Diego City Council, by the following votes: Yeas, District 1, 2, 3, 4, 6, 7, and 8; Nays: District 5; Absent: District 9, approved the settlement of the Litigation for an amount consistent with the amounts set forth below and pursuant to such other terms more fully set forth in the settlement agreement;

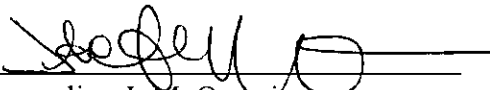
NOW, THEREFORE,

BE IT RESOLVED, by the City Council of the City of San Diego, that the Council:

1. Authorizes the Mayor or his designee to pay the sum of \$8,000,000.00 from the Public Liability Fund No. 720045, in settlement of each and every claim for damages, interest, costs, and fees of any type, including attorney fees, against City of San Diego, its agents and employees, arising from the complaint filed by Deovante Guy, by and through his Guardian ad Litem, Quintasia Walker,

2. Authorizes the Chief Financial Officer to expend an amount not to exceed \$8,000,000.00 from the Public Liability Fund No. 720045, for the purpose of settling this claim.

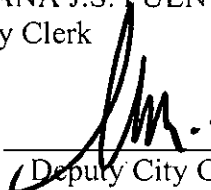
