A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO AUTHORIZING THE USE OF CITY FORCES TO COMPLETE CONSTRUCTION OF CIP S-24008, SD EAST OF RACHAEL AVE SWD AND APPROPRIATION AND EXPENDITURE OF CAPITAL IMPROVEMENTS PROGRAM BUDGET FUNDS FOR CITY FORCE RELATED EXPENSES, CONSTRUCTION AND RELATED ACTIVITIES.

WHEREAS, failing Corrugated Metal Pipes (CMP) in the City of San Diego (City) stormwater collection system are the primary cause of stormwater drainage system failure requiring the City to implement costly emergency repairs; and

WHEREAS, the City is committed to repair and replace all CMP to prevent costly emergency repairs, major transportation interruptions, and public liability costs; and

WHEREAS, in June 2018, the Office of the City Auditor conducted a performance audit of the City's Stormwater Department (Department) and recommended that the Department: (1) use City forces to replace CMP more quickly and efficiently; and (2) complete an analysis to support plans to optimize the size of the Department's in-house CMP repair crew; and

WHEREAS, in 2019, the Department reviewed existing CMP segments to assess repair options for individual pipe segments; and

WHEREAS, Department analysis identified 8.48 miles of CMP out of a total of 32.2 miles with the appropriate characteristics for in-house repair or replacement by City forces; and

WHEREAS, the Council of the City of San Diego (Council) previously approved a second stormwater pipe repair crew by Ordinance Number O-21348 and the Department is positioned to perform one mile of CMP replacement per year, in-house by City forces, and to fully replace the identified 8.48 miles of CMP thereby necessitating in-house Capital

Improvements Program (CIP) projects to replace the identified CMP; and

WHEREAS, on October 10, 2023, the Council approved the addition of CIP S-24008, SD East of Rachael Ave SWD, to the CIP and authorized an increase to the CIP Budget in CIP S-24008, SD East of Rachael Ave SWD, and appropriation and expenditure of \$2,748,800 to fund preliminary design and planning activities for the SD East of Rachael Ave SWD project; and

WHEREAS, this CIP project is in a location that experiences frequent flooding due to an inadequate and aged drainage system; and

WHEREAS, the requested appropriations will fund the construction of the SD East of Rachael Ave SWD Project located in the Skyline-Paradise Hills Community Plan Area within Council District 4 and bounded by Gables Street to the North, Rachael Avenue to the West, Cumberland Street to the South, and Sea Breeze Drive to the East; and

WHEREAS, the estimated project construction cost per fiscal year is listed below:

WHEREAS, this in-house CIP project will alleviate flooding and erosion problems through the replacement, abandonment, upgrade, and realignment to the right of way of existing CMP, install a total of 8,215 feet of new Reinforced Concrete Pipes, with 3,442 feet installed in FY24 and 4,773 feet installed in FY25, and install inlets and cleanouts to ensure the installed

pipe systems properly convey stormwater flow and can be properly maintained; and

WHEREAS, funding for the in-house CIP project is currently available in Fund 400881, Debt Funded General Fund CIP, and Fund 400884, General Fund WIFIA Loan - Construction; and

WHEREAS, San Diego Municipal Code section 22.3105 requires Council approval for the use of City forces on a public works project if the cost of using such forces exceeds \$500,000 and the cost of using City forces for this in-house CIP project will exceed this amount; and

WHEREAS, the Office of the City Attorney has drafted this resolution based on the information provided by City staff, with the understanding that this information is complete, true, and accurate; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego that the Mayor, or his designee, is authorized to use City Forces to complete the construction of CIP S-24008, SD East of Rachael Ave SWD.

BE IT FURTHER RESOLVED, by the Council of the City of San Diego that the Mayor, or his designee, is authorized to expend funds not to exceed \$20,358,815.20 from fund 400881, Debt Funded General Fund CIP, for City Force Work related expenses.

BE IT FURTHER RESOLVED, that the Chief Financial Officer is authorized to increase the Capital Improvements Program Budget in CIP S-24008, SD East of Rachael Ave SWD and to appropriate and expend \$24,721,319.00; of which, \$19,859,055.20 is from Fund 400881, Debt

Funded General Fund CIP, and \$4,862,263.80 is from Fund 400884, General Fund WIFIA Loan-Construction, for the purpose of funding construction and post-construction activities.
