A RESOLUTION OF THE COUNCIL OF THE CITY OF  
SAN DIEGO APPROVING THE SETTLEMENT BETWEEN  
ROSA CALVA-GARCIA AND THE CITY OF SAN DIEGO.

WHEREAS on September 30, 2022, Rosa Calva-Garcia filed suit against the City of San Diego alleging personal injuries arising from a May 23, 2020, arrest for assault with a deadly weapon at 1245 Market Street in the City of San Diego. The lawsuit is captioned *Rosa Calva-Garcia v. City of San Diego, et al.*, United States District Court Case No. 22cv01478-MMA-SBC; and

WHEREAS, in Closed Session on September 11, 2023, the City Council by the following votes: Yea, Districts 1, 2, 3, 4, 5, 6, 7, and 8; Absent, District 9; Nays, None; approved the settlement for an amount consistent with the amounts set forth below; NOW, THEREFORE,


BE IT RESOLVED, by the City Council of the City of San Diego, that the City Council:

1. Authorizes the Mayor or his designee to pay the sum of \$325,000.00 from Public Liability Fund No. 720045, in settlement of each and every claim for damages, interest, costs and fees of any type, including attorney fees, against the City of San Diego, its agents and employees, arising from the personal injury complaint filed by Plaintiff Rosa Calva-Garcia.

2. Authorize the Chief Financial Officer to expend \$325,000.00 from Public Liability Fund No. 720045 for the purpose of settling this claim.


