A RESOLUTION OF THE COUNCIL OF THE CITY OF  
SAN DIEGO APPROVING THE SETTLEMENT BETWEEN  
ARTHUR ARAGON AND THE CITY OF SAN DIEGO.

WHEREAS, on November 26, 2019, Arthur Aragon filed a lawsuit against the City of San Diego for injuries allegedly caused on October 27, 2018, when Plaintiff fell while holding onto an unsecured handrail on a ramp at the San Diego County Credit Union Stadium. The lawsuit is entitled *Arthur Aragon v. City of San Diego*, San Diego Superior Court 37-2019-00063223-CU-PO-CT; and

WHEREAS, in Closed Session on September 18, 2023, the City Council, by the following votes: Yeas, Districts 1, 2, 3, 4, 5, 6, 7, and 8; Nays 0; and Absent District 9, approved the Settlement for an amount consistent with the amounts set forth below; and NOW THEREFORE,

BE IT RESOLVED, by the City Council of the City of San Diego, that the Council:

1. Authorizes the Mayor or his designee to pay the sum of \$131,250.00 from Public Liability Fund No. 720045, in settlement of each and every claim for damages, interest, costs, and fees of any type, including attorney fees, against City of San Diego, its agents and employees, arising from the complaint filed by Arthur Aragon;

2. Authorizes the Chief Financial Officer to expend an amount not to exceed \$131,250.00 from Public Liability Fund No. 720045, for the purposes of settling this claim.




