A RESOLUTION OF THE COUNCIL OF THE CITY OF
SAN DIEGO ADOPTING THE LIBRARY MASTER PLAN.

WHEREAS, the Library Master Plan is a comprehensive new vision, framework, and long-range guide for future library improvements in the City of San Diego; and

WHEREAS, the Library Master Plan is intended to build on and supersede the City's previous Library Building Plan, which was created in 2002 and has driven new and expanded library facilities for more than 20 years; and

WHEREAS, in 2019, a new master planning process was initiated to assess the state of the City's library network, confirm the needs and vision for library facilities, and establish a framework along with guiding principles for future decades of library facility improvements; and

WHEREAS, the Library Department conducted extensive public outreach engaging over 11,000 San Diegans during an over four-year planning effort, which identified the need to deliver libraries and library services that meet the community's needs by being equitable, engaging and experiential, geographically accessible everywhere, and empowered with the necessary resources to thrive; and

WHEREAS, the Library Master Plan identifies key general recommendations for each library in the San Diego Public Library system that will be critical to the Library Master Plan's successful and equitable implementation; and

WHEREAS, on January 6, 2022, the Library Master Plan Framework was completed and used as a basis to develop the Library Master Plan; and

WHEREAS, on September 22, 2021, and again on November 16, 2022, the Public Safety and Livable Neighborhoods Council Committee heard informational items on the Library Master Plan Framework; and

WHEREAS, on January 10, 2023, the City Council (Council) heard an informational item on the Library Master Plan Framework; and

WHEREAS, on September 6, 2023, a draft Library Master Plan was made available to the public for review; and

WHEREAS, on October 5, 2023, the Community and Neighborhood Services Council Committee voted unanimously to recommend adoption of the Library Master Plan; and

WHEREAS, the Council held a public hearing for the purpose of considering the adoption of the City of San Diego Library Master Plan; and

WHEREAS, the Office of the City Attorney has drafted this resolution based on the information provided by City staff, with the understanding that this information is complete, true, and accurate; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego that the Council approves the Library Master Plan, on file in the Office of the City Clerk as Document No.
