A RESOLUTION OF THE COUNCIL OF THE CITY OF
SAN DIEGO AUTHORIZING THE EXECUTION OF
CONSTRUCTION CHANGE ORDER NO. 2 TO THE
AGREEMENT (K-21-1968-DBB-3) WITH TC
CONSTRUCTION, INC. FOR CONSTRUCTION OF THE
SEWER AND AC WATER GROUP 763 PROJECT.

WHEREAS, in April 2021, the City of San Diego (City) entered into agreement K-21-1968-DBB-3 (Agreement) for construction of the Sewer and AC Water Group 763 project (Project) with TC Construction, Inc. (Contractor); and

WHEREAS, the Agreement was originally scoped for slurry seal, but due to the condition of the roads, a 2-inch and 3-inch full width cold mill and AC inlay on residential streets and major streets, respectively, is now recommended; and

WHEREAS, the City desires to execute Construction Change Order No. 2 to the Agreement to add 15 working days and an agreed upon, not to exceed amount of \$850,000.00 in order for the Contractor to perform the above-referenced road resurfacing within the Project; and

WHEREAS, the Office of the City Attorney has drafted this resolution based on the information provided by City staff with the understanding that this information is complete, true, and accurate; NOW, THEREFORE,


BE IT RESOLVED, by the Council of the City of San Diego, as follows:

1. That the Mayor, or his designee, is authorized to execute Construction Change Order No. 2 to the Agreement to add 15 working days and an amount not to exceed \$850,000.00.
2. That the Chief Financial Officer is authorized to expend an additional amount not to exceed \$850,000.00 from, CIP A-ID.00005, Street Resurfacing and Reconstruction, [B-23113, Sewer and AC Water Group 763 (P)], of which \$468,496.57 from Fund #200118, GAS TAX ST

IMPR-ANN , \$226,119.76 from Fund #400169, TRANSNET EXTENSION 7 and \$155,383.67 from Fund #400869, GEN FUND COMM PAPER, for the construction of Sewer and AC Water Group 763 (P).


