WHEREAS, based on the selection criteria, the City issued a notice of intent to award to Alta Land Surveying, Inc. (Consultant); and

WHEREAS, the work to be performed under this Agreement will be completed on a taskby-task basis. The proposed Agreement is required to address the City's needs in a timely manner to meet required schedules; and

Surveying, Aerial Surveying, Photography, Mapping and Digitizing Services, for a minimum of

\$1,000 and a total amount not to exceed \$5,000,000 for the duration of three years under the

terms and conditions set forth in the Agreement on file in the Office of the City Clerk as

Document No. RR-315203 is approved.

2. The Mayor, or designee, is authorized to execute and deliver the Agreement; and

3. The Chief Financial Officer is authorized to appropriate and expend an amount

not to exceed \$5,000,000, with a minimum guarantee coming from CIP A-JA.00001, Sewer

Mains, Fund 700008, Sewer Utility CIP, for the purpose of funding the Agreement, contingent

upon the adoption of the Annual Appropriation Ordinance for the applicable fiscal year and

contingent upon the Chief Financial Officer furnishing one or more certificates certifying that

funds necessary for expenditure are, or will be, on deposit with the City Treasurer.
