WHEREAS, under Charter section 280(a)(1) this Resolution is not subject to veto by the Mayor, because this matter is exclusively within the purview of the Council and not affecting the administrative service of the City under the control of the Mayor; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, that the schedule of meetings for the Council, Standing Committees, and Budget Review Committee of the City Council, and meetings of the Housing Authority and Public Facilities Financing Authority, for the period of January 1, 2024 through December 31, 2024, a copy of which is on file in the Office of the City Clerk as Document No. RR- 315209. is hereby adopted.
