A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO DENYING THE APPEAL OF THE HISTORICAL DESIGNATION OF THE MAMIE AND OLIVER EVANS/ WILLIAM TEMPLETON JOHNSON HOUSE LOCATED AT 4388 AMPUDIA STREET AND AFFIRMING THE DECISION OF THE HISTORICAL RESOURCES BOARD TO DESIGNATE THE PROPERTY AS A HISTORICAL RESOURCE.

WHEREAS, on April 27, 2023, the San Diego Historical Resources Board (HRB) designated the Mamie and Oliver Evans/Willliam Templeton Johnson House located at 4388 Ampudia Street, as a historical resource under HRB Criterion C as an example of the Spanish Colonial Revival style and HRB Criterion D as a notable work of Master Architect William Templeton Johnson; and

WHEREAS, on May 7, 2023, Clint Daniels (appellant) filed an appeal with the City clerk, with additional materials in support of the appeal filed by the appellant on June 27, 2023, August 27, 2023, and November 1, 2023; and

WHEREAS, on appeal, the City Council may by resolution affirm, reverse, or modify the determination of the HRB; and

WHEREAS, on appeal, the City Council may reject the HRB's designation of a property as a historical resource on the basis of factual errors in materials or information presented to the HRB, violations of bylaws or hearing procedures by the HRB or an individual member, or presentation of new information; and

WHEREAS, the matter was set for public hearing on November 7, 2023, testimony having been heard, evidence having been submitted, and the City Council having fully considered the matter and being fully advised concerning the same; and WHEREAS, the City Council finds that there is no basis to reject the HRB's designation of the property as a historical resource; and

WHEREAS, the Office of the City Attorney has drafted this resolution based on the information provided by City staff, including information provided by affected third parties and verified by staff, with the understanding that this information is complete, true, and accurate; and

WHEREAS, under San Diego Charter section 280(a)(2), this resolution is not subject to veto by the Mayor because this matter requires the City Council to act as a quasi-judicial body and where a public hearing was required by law implicating due process rights of individuals affected by the decision and where the City Council was required by law to consider evidence at the hearing and to make legal findings based on the evidence presented; NOW, THEREFORE,

BE IT RESOLVED, by the City Council of the City of San Diego, that the appeal of the Mamie and Oliver Evans/Willliam Templeton Johnson House, located at 4388 Ampudia Street, as a designated historical resource is denied, the decision of the Historical Resources Board is affirmed and that the Mamie and Oliver Evans/Willliam Templeton Johnson House, located at 4388 Ampudia Street, is designated a historical resource.
