Jones filed a lawsuit for injuries allegedly caused by the actions of a City of San Diego Environmental Services Department employee as a result of an illegal left-hand turn made in front of Plaintiff at the intersection of Murray Ridge Road and Larkdale Avenue on July 1, 2020. The lawsuit is entitled *Tanner M. Jones v. City of San Diego, et al.*, San Diego Superior Court Case No. 37-2021-00006326-CU-PA-CTL (Litigation); and

WHEREAS, in Closed Session on October 9, 2023, the City Council, by the following vote: Yeas, Districts 2, 4, 6, 7, and 9; Nays, None; and Absent, Districts 1, 3, 5, and 8, approved the Settlement for an amount consistent with the amount set forth below; and NOW, THEREFORE,

BE IT RESOLVED, by the City Council of the City of San Diego, that the Council:

1. Authorizes the Mayor or his designee to pay the sum of \$150,000.00 from Public Liability Fund No. 720045 in settlement of each and every claim for damages, interest, costs, and fees of any type, including attorney fees, against City of San Diego, its agents and employees, arising from the Litigation.

2. Auth	orizes the Chief Financial Off	ficer to expend an amount not to exceed
\$150,000.00 from F	Public Liability Fund No. 7200	945, for the purpose of settling this claim.
