A RESOLUTION OF THE COUNCIL OF THE CITY OF  
SAN DIEGO APPROVING THE SETTLEMENT BETWEEN  
JULI HUGHES AND THE CITY OF SAN DIEGO

WHEREAS, On November 9, 2021, Juli Hughes filed suit against the City of San Diego alleging injuries that occurred from a trip and fall on March 7, 2020. The lawsuit is titled *Juli Hughes v. City of San Diego, et al.*, San Diego Superior Court Case No. 37-2021-00047593-CU-PO-CTL (Litigation); and


WHEREAS, in Closed Session on September 11, 2023, by the following votes: Yeas, Districts 1, 2, 3, 4, 5, 6, 7, and 8; Nays, none; and Absent, District 9; approved the Settlement for an amount consistent with the amounts set forth below; NOW, THEREFORE,

BE IT RESOLVED, by the City Council of the City of San Diego, that the Council:

1. Authorizes the Mayor or his designee to pay the sum of \$150,000.00 from Public Liability Fund No. 720045, in settlement of each and every claim for damages, interest, costs, and fees of any type, including attorney fees, against the City of San Diego, its agents and employees, arising from the Litigation.

2. Authorizes the Chief Financial Officer to expend an amount not to exceed \$150,000.00 from Public Liability Fund No. 720045, for the purpose of settling the Litigation.




