

RESOLUTION NUMBER R- **315232**DATE OF FINAL PASSAGE **DEC 04 2023**A RESOLUTION OF THE COUNCIL OF THE CITY OF  
SAN DIEGO SELECTING A COUNCIL PRESIDENT.

WHEREAS, San Diego Charter section 270(d) provides that the Council of the City of San Diego (Council) shall have the right to determine its own rules and order of business, including a process for selecting a presiding officer to chair Council meetings and manage the docket process; and

WHEREAS, Rule 4.2 of the Rules of the Council, San Diego Municipal Code section 22.0101, provides that the Council shall, in odd-numbered years, at the first Monday Council meeting held in December, select a Council President from one of its members by majority vote, to serve for a term of one year or until a successor is selected and qualified, whichever is later; and

WHEREAS, it is now necessary for the Council to select one of its members to serve as Council President; and


WHEREAS, the Office of the City Attorney has drafted this resolution based on the information provided by City staff, with the understanding that this information is complete, true, and accurate; and

WHEREAS, under Charter section 280(a)(1), this resolution is not subject to veto by the Mayor because this matter is exclusively within the purview of the Council and not affecting the administrative service of the City under the control of the Mayor; NOW THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, that after full discussion and deliberation by the Council, Councilmember Elo-Rivera is hereby selected as Council President to serve a one-year term commencing on December 4, 2023, and until a successor is selected and qualified.
