A RESOLUTION OF THE COUNCIL OF THE CITY OF
SAN DIEGO APPROVING THE SETTLEMENT BETWEEN
KRISTOPHER FUKUDA, ET AL. AND THE CITY OF SAN
DIEGO

WHEREAS, on August 19, 2020, Plaintiffs filed suit in San Diego Superior Court against the City of San Diego. The suit is entitled *Kristopher Fukuda et al. v. City of San Diego*, San Diego Superior Court Case No. 37-2020-00022522-CU-EI-CTL (the Litigation); and

WHEREAS, in Closed Session on October 16, 2023, the City Council, by the following votes: Yeas, Districts 1, 2, 3, 5, 6, and 9; Nays, None; and Absent, Districts 4, 7, and 8; authorized settlement of the Litigation for an amount consistent with the amounts set forth below and pursuant to such other terms more fully set forth in the Settlement and Release Agreement; NOW, THEREFORE,


BE IT RESOLVED, by the City Council of the City of San Diego, that the Council:

1) Authorizes the Mayor or his designee to pay the sum of \$850,000.00 from Public Liability Fund No. 720045, in settlement of each and every claim for damages, interest, costs, and fees of any type, including attorney fees, against City of San Diego, its agents and employees, arising from the Litigation.

2) Authorize the Department of Finance to expend an amount not to exceed \$850,000.00 from Public Liability Fund No. 720045, for the purpose of settling this claim.
