A RESOLUTION OF THE COUNCIL OF THE CITY OF
SAN DIEGO ESTABLISHING COUNCIL POLICY 900-23
TITLED COMPLETE STREETS.

WHEREAS, Complete Streets are transportation facilities that are planned, designed, implemented, operated, and maintained to provide a well-connected network of multimodal facilities and services that provide greater mobility options to the public; and

WHEREAS, the Complete Streets Council Policy (Policy) provides guidance in identifying viable improvements to existing City of San Diego (City) corridors consistent with Complete Streets planning concepts and strategies to create dynamic, vibrant corridors for all modes of travel; and

WHEREAS, the City has adopted several plans that outline the development of City roadways and mobility systems, and the City's General Plan sets forth goals and policies for enhancing the quality of life in communities through a balanced, multimodal mobility system; and

WHEREAS, the Council of the City of San Diego (Council) also approved an updated Climate Action Plan (CAP) in 2022, setting a goal of net zero emissions by 2035 and an associated transition to more sustainable modes of transportation; and

WHEREAS, the City has also committed to improving safety for all roadway users through the Vision Zero Strategic Plan and its goal of eliminating traffic fatalities and severe injuries; and

WHEREAS, this Council Policy for Complete Streets will provide guiding policies for projects within the public right-of-way to be consistent with these adopted plans and initiatives and will further the attainment of a balanced, multimodal mobility system with increased travel options and supportive infrastructure; and

WHEREAS, the Office of the City Attorney has drafted this resolution based on the information provided by City staff, including information provided by affected third parties and verified with City staff with the understanding that this information is complete, true, and accurate; NOW, THEREFORE,


BE IT RESOLVED, by the Council of the City of San Diego, as follows:
