A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO CONFIRMING THE SELECTION OF A COUNCIL PRESIDENT PRO TEM.

WHEREAS, San Diego Charter section 270(d) gives the Council of the City of San Diego (Council) the right to determine its own rules and order of business, including a process for the selection of a Council President to chair meetings and manage the docket process, and a President Pro Tem to perform such duties when the President is absent or unable to perform those duties; and

WHEREAS, Rule 4.3 of the Rules of the Council, in San Diego Municipal Code section 22.0101, provides that the Council President shall select a President Pro Tem, subject to confirmation by a majority of the Council; and

WHEREAS, the Council President Pro Tem shall serve for a term of one year or until a successor is selected and qualified, whichever is later, and the position is not subject to term limits; and

WHEREAS, Council President Sean Elo-Rivera selected Councilmember

Joe LaCava to serve as Council President Pro Tem, subject to confirmation by the Council; and

WHEREAS, the Office of the City Attorney has drafted this resolution based on the information provided by City staff, with the understanding that this information is complete, true, and accurate; and

WHEREAS, under Charter section 280(a)(1), this resolution is not subject to veto by the Mayor because this matter is exclusively within the purview of the Council and not affecting the administrative service of the City under the control of the Mayor; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, that after full discussion and deliberation, the Council confirms, selection of Councilmember Joe LaCava to serve as Council President Pro Tem for a one-year term, commencing on December 11, 2023, or until a successor is selected and qualified, whichever is later, in accordance with the Rules of the Council in the San Diego Municipal Code.
