

RESOLUTION NUMBER R- 315272DATE OF FINAL PASSAGE DEC 22 2023A RESOLUTION OF THE COUNCIL OF THE CITY OF
SAN DIEGO PRICE V. CITY OF SAN DIEGO.

WHEREAS, on June 8, 2020, Plaintiffs Arthur Price, Cherrie Dosio, Keither Reid, Patrick Quinones, and Christopher Voelp (now the Estate of Christopher Voelp) filed a complaint against the City of San Diego (City) for discrimination related causes of action resulting from Plaintiffs' alleged inability to access various homelessness programs and activities during the COVID-19 pandemic. Plaintiffs brought suit in the Superior Court of California, County of San Diego. The suit is entitled Arthur Price, et al. v. City of San Diego, et al., San Diego Superior Court Case No. 37-2020-00019535-CU-MC-CTL; and

WHEREAS, in Closed Session on September 11, 2023, the City Council, by the following votes: Yeas, district(s) 1, 2, 3, 4, 5, 6, 7, 8, and 9; Nays, None; and Absent, None, approved the settlement; and

WHEREAS, the City Council in closed session on September 11, 2023, authorized settlement of the Litigation for an amount consistent with the amounts set forth below and under such other terms more fully set forth in the Settlement Agreement; and

WHEREAS, the Office of the City Attorney has drafted this resolution based on the information provided by City staff, with the understanding that this information is complete, true, and accurate;

NOW, THEREFORE,


BE IT RESOLVED, by the City Council of the City of San Diego, that the Council:

1. Authorizes the Mayor or his designee to pay the sum of \$100,000 from Public Liability Fund No. 720045, in settlement of each and every claim for damages, interest, costs, and fees of any type, including attorney fees, against City of San Diego, its agents, employees

and contractors arising from the discrimination complaint filed by Plaintiffs Arthur Price, Cherrie Dosio, Keither Reid, Patrick Quinones, and Christopher Voelp (now the Estate of Christopher Voelp).

2. Authorizes the Department of Finance to expend an amount not to exceed \$100,000 from Public Liability Fund No. 720045, for the purposes of settling this claim.
