A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO APPROVING A SIDE LETTER AGREEMENT BETWEEN THE CITY AND THE SAN DIEGO POLICE OFFICERS ASSOCIATION, TO AMEND ARTICLE 77 OF THE MEMORANDUM OF UNDERSTANDING RELATED TO PAID SICK LEAVE FOR HOURLY EMPLOYEES.

WHEREAS, by San Diego Resolution R-314185 (June 23, 2022) and Resolution

R-314945 (June 12, 2023), the San Diego City Council approved a Memorandum of

Understanding (MOU) between the City of San Diego and the San Diego Police Officers

Association (POA) regarding terms and conditions of employment for employees represented by

POA for fiscal years 2023 and 2024; and

WHEREAS, on October 4, 2023, Governor Gavin Newsom approved Senate Bill 616,

which will be effective on January 1, 2024. SB 616 requires employers to provide their

employees up to 40 hours or five days, whichever is more, of accrued paid sick leave each year

or 12-month period; and allow employees to accrue up to a maximum of 80 hours or ten days,

whichever is more, of paid sick leave; and

WHEREAS, the City and POA entered into a side letter agreement (Agreement) to amend Article 77 of the MOU related to paid sick leave for hourly employees to comply with SB 616; and

WHEREAS, the Agreement must be approved by a two-thirds majority vote of the Council to take effect, in accordance with Charter section 11.2; and WHEREAS, the Office of the City Attorney has drafted this resolution based on the information provided by City staff, including information provided by affected third parties and verified by City staff, with the understanding that this information is complete, true, and accurate; NOW, THEREFORE,
