A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO APPROVING A SIDE LETTER AGREEMENT BETWEEN THE CITY AND THE SAN DIEGO POLICE OFFICERS ASSOCIATION, TO AMEND ARTICLE 69 OF THE MEMORANDUM OF UNDERSTANDING RELATED TO BEREAVEMENT LEAVE FOR REPRODUCTIVE LOSS EVENTS.

WHEREAS, by San Diego Resolution R-314185 (June 23, 2022), the San Diego City Council approved a Memorandum of Understanding (MOU) between the City of San Diego and the San Diego Police Officers Association (POA) regarding terms and conditions of employment for employees represented by POA for fiscal years 2023 and 2024; and

WHEREAS, on October 10, 2023, Governor Gavin Newsom signed Senate Bill 848 into law, which goes into effect on January 1, 2024. SB 848 amends the California Fair Employment and Housing Act to allow employees who have been employed for at least 30 days (eligible employees) up to five days of unpaid reproductive loss leave following a reproductive loss event, as defined, taken within three months of the event. Eligible employees are limited to up to 20 days of unpaid reproductive loss leave within a 12-month period; and

WHEREAS, the City and POA entered into a side letter agreement (Agreement) to amend Article 69 of the MOU by adding unpaid reproductive loss leave to the existing unpaid bereavement leave provision, and authorize eligible employees to use this unpaid bereavement leave within 12 months following a reproductive loss event; and

WHEREAS, the Agreement must be approved by a two-thirds majority vote of the Council to take effect, in accordance with Charter section 11.2; and WHEREAS, the Office of the City Attorney has drafted this resolution based on the information provided by City staff, including information provided by affected third parties and verified by City staff, with the understanding that this information is complete, true, and accurate; NOW, THEREFORE,

BE IT RESOLVED, by the City Council of the City of San Diego, that the Agreement between the City and POA to amend Article 69 of the MOU related to bereavement leave for reproductive loss events, presented to the Council and on file in the Office of the City Clerk as Document No. RR-<u>315280</u>, is approved, and takes effect upon the date of final passage of this Resolution.
