AN ORDINANCE OF THE COUNCIL OF THE CITY OF SAN DIEGO APPROVING A THIRD AMENDMENT TO THE CARAHSOFT/EPLANSOFT CONTRACT C1407 FOR ELECTRONIC PLAN REVIEW BY EXTENDING THE TERM OF THE CONTRACT FOR TWO YEARS AND INCREASING THE CONTRACT'S NOT-TO-EXCEED AMOUNT BY \$2,567,175.

WHEREAS, ePlansoft is a cloud-based application that assists City plan reviewers in assigning workloads, conducting simultaneous plan reviews, providing comments to customers, generating reports, and stamping approved plans; and

WHEREAS, this application directly integrates with the implemented Accela permit system and is an essential tool in reviewing thousands of building and engineering permit applications annually; and

WHEREAS, ePlanSoft was acquired using a cooperative contract C1407 with Carahsoft Technology for Cloud Solutions and expires on May 30, 2024 after a five-year term. Contract C1746 - Hosting and Maintenance Services for City's Accela System, SS 4158, expires on September 29, 2025; and

WHEREAS, the Development Services Department is in the process of executing a formal solicitation that combines both specifications for the current Carahsoft/ePlanSoft and Accela Systems contract; and

WHEREAS, this ordinance will extend the C1407 Carahsoft/ePlansoft contract for another two years to allow for the formal solicitation of the combined contract to be completed; and

WHEREAS, under Charter section 99 this contract needs to be extended by an ordinance of the City Council because with this amendment the term of the contract will extend beyond five years; and

WHEREAS, the Office of the City Attorney has drafted this ordinance based on the information provided by City staff, including information provided by affected third parties and verified by City staff, with the understanding that this information is complete, true, and accurate; and

WHEREAS, under San Diego Charter section 99, a supermajority vote of the City Council is required for passage of this ordinance; NOW, THEREFORE,

BE IT ORDAINED, by the Council of the City of San Diego, as follows:

Section 1. That the Mayor or his designee is authorized to enter into and execute a third amendment to the Carahsoft/ePlansoft contract to extend the effective date of that contract through September 15, 2026, and increase the not-to-exceed (NTE) amount by \$2,567,175 (total NTE of \$6,500,000).

Section 2. That the Chief Financial Officer is able to expend a NTE amount of \$6,500,000 over the full term of the contract contingent upon the adoption of the Appropriation Ordinance for the appropriate fiscal year and contingent upon the Chief Financial Officer furnishing a certificate certifying that funds necessary for expenditure are, or will be, on deposit with the City Treasurer.

Section 3. That a full reading of this ordinance is dispensed with prior to passage, a written copy having been made available to the Council and the public prior to the day of its passage.
