DATE OF FINAL PASSAGE AUG 05 2024

AN ORDINANCE OF THE COUNCIL OF THE CITY OF SAN DIEGO AUTHORIZING THE FIRST AMENDMENT TO THE AS-NEEDED TRANSPORTATION ENGINEERING SERVICES AGREEMENT WITH KIMLEY-HORN AND ASSOCIATES, INC. (H186985).

WHEREAS, the City of San Diego (City) utilizes as-needed transportation engineering services agreements in support of its Capital Improvement Program (CIP) and other public projects; and

WHEREAS, being able to issue task orders under an as-needed agreement proves beneficial and efficient in the timely procurement of transportation engineering services; and

WHEREAS, on August 23, 2019, the City executed the As-Needed Transportation Engineering Services Agreement (H186985) with Kimley-Horn and Associates, Inc. (Agreement), to provide transportation engineering services for CIP projects which include, but are not limited to, the preparation of construction drawings, contract documents, construction period services, and preparation of various reports; and

WHEREAS, of the twenty-two total task orders issued under the Agreement, eight are for CIP projects currently under design and construction, and completion of these eight task orders will extend beyond the Agreement expiration date of August 22, 2024; and

WHEREAS, a First Amendment to the Agreement (First Amendment) will be necessary to extend the duration of the Agreement from 60 months to 84 months to complete the remaining eight task orders; and

WHEREAS, this First Amendment will allow for completion of the following eight task orders: Accelerated Sewer 852 - Deep Manhole Design, AC Overlay 2200 Curb Ramp and TCP Design, Black Mountain Discharge Channel Access Stairs, Morena Improvement 2 (W&S),

Pacific Beach Improv-1, Sewer and AC Water Group 1055, Market Street - 47th St. to Euclid Complete St Project and Kensington Improvements 1.

WHEREAS, under San Diego Charter section 99, no contract, agreement, or obligation extending for a period of more than five years may be authorized except by ordinance approved by a two-thirds majority vote of the City Council; and

WHEREAS, the Office of the City Attorney has drafted this Ordinance based on the information provided by City staff, with the understanding that this information is complete, true, and accurate; NOW, THEREFORE,

BE IT ORDAINED, by the Council of the City of San Diego, as follows:

Section 1. That the Mayor, or his designee, is authorized to execute, for and on behalf of the City, this First Amendment with Kimley-Horn and Associates, Inc. (H186985) to extend the Agreement duration from 60 months to 84 months, to complete the eight task orders identified above, under the terms and conditions set forth in the First Amendment, on file in the Office of the City Clerk as Document No. OO- **21852**.

Section 2. That a full reading of this Ordinance is dispensed with prior to passage, a written or printed copy having been made available to the City Council and the public prior to the day of its passage.

Section 3. That this Ordinance shall take effect and be in force on the thirtieth day from and after its final passage.
