DATE OF FINAL PASSAGE SEP 16, 2024

AN ORDINANCE OF THE COUNCIL OF THE CITY OF SAN DIEGO AUTHORIZING AN AGREEMENT BETWEEN THE CITY OF SAN DIEGO AND THE SAN DIEGO COUNTY REGIONAL AIRPORT AUTHORITY FOR THE SAN DIEGO FIRE-RESCUE DEPARTMENT TO PROVIDE REIMBURSABLE EMERGENCY MEDICAL SERVICES AT THE SAN DIEGO INTERNATIONAL AIRPORT.

WHEREAS, the City of San Diego is responsible to develop and operate emergency medical services (EMS) within the City's exclusive operating area (EOA) in accordance with applicable California law. The San Diego International Airport (Airport) is within the City's EOA; and

WHEREAS, to comply with state law, the San Diego Fire-Rescue Department (SDFD), through its contracted EMS ambulance provider, provided standby EMS services at the Airport under a reimbursable agreement with San Diego County Regional Airport Authority (SDCRAA) that expired on June 30, 2024; and

WEHERAS, SDFD and SDCRAA have met and agreed that SDFD would continue to provide EMS services at the Airport. The proposed Agreement would run retroactive from July 1, 2024, through June 30, 2029, with options to renew for two additional one-year terms (Agreement); and

WHEREAS, The Agreement has a total value not to exceed \$12,000,000 for the initial five years. If the City exercises the first one-year renewal option, the total value will increase to \$15,000,000. Exercising the second one-year renewal option would further raise the total value to a maximum of \$18,000,000. The funding source for the Agreement will be the Emergency

Medical Services Transport Program Fund, Fund 200227. This is a cost-recoverable amount resulting in no fiscal impact to the City; and

WHEREAS, the Agreement will continue the contractual relationship between the City and SDCRAA, requiring compliance with San Diego Charter section 99, which provides (subject to certain exceptions) that no contract, agreement, or obligation creating City indebtedness and extending for a period of more than five years may be authorized except by an ordinance adopted by a two-thirds majority of the City Council; and

WHEREAS, the Office of the City Attorney has drafted this ordinance based on the information provided by City staff, with the understanding that this information is complete, true, and accurate; NOW, THEREFORE,

BE IT ORDAINED, by the Council of the City of San Diego, as follows:

Section 1. That the Mayor, or his designee, is hereby authorized to execute, for and on behalf of the City, a five-year Agreement with two additional one-year options to renew with San Diego County Regional Airport Authority for the Fire-Rescue Department to provide paramedic services at the San Diego International Airport, for an amount not to exceed: \$12,000,000 in the initial term or \$18,000,000 if both one-year options are exercised, under the terms and conditions set forth in the Agreement, on file with the Office of the City Clerk as Document No. OO- **21.862**

Section 2. The Chief Financial Officer is authorized to appropriate and expend funds under the Agreement in an amount not to exceed \$12,000,000 from the Emergency Medical Services Transport Program Fund, Fund 200227, Fire-Rescue Business Area 1913, over the first five years of the agreement, or up to \$18,000,000 if both one-year options are exercised,

contingent upon the Chief Financial Officer furnishing one or more certificates certifying that funds necessary for expenditure are, or will be, on deposit with the City Treasurer.

Section 3. That this Ordinance apply retroactively to July 1, 2024, to continue the contractual relationship between the City and SDCRAA without a break in services.

Section 4. The Council dispenses with a full reading of this Ordinance before its passage because a written copy of this Ordinance was made available to the Council and the public before the date of its passage.

Section 5. This Ordinance will take effect and be in force on the thirtieth day from and after its final passage.
