ORDINANCE NUMBER O- 21873 (NEW SERIES)

DATE OF FINAL PASSAGE OCT 03 2024

AN ORDINANCE OF THE COUNCIL OF THE CITY OF SAN DIEGO AUTHORIZING THE EXECUTION OF A SEVEN YEAR AGREEMENT WITH DOKKEN ENGINEERING FOR THE GOLDEN HILL IMPROV 1 PROJECT IN AN AMOUNT NOT TO EXCEED \$1,998,962.00 AND RELATED ACTIONS.

WHEREAS, the Golden Hill Improv 1 Project (Project) is part of the City of San Diego's Engineering & Capital Projects Department's "Group Jobs" which consists of replacing the city's aging water and sewer systems; and

WHEREAS, the City issued a Request for Proposal (H2326125) to solicit professional engineering services for design of the Project; and

WHEREAS, four firms submitted proposals and Dokken Engineering was selected based upon their qualifications in accordance with Council Policy 300-07; and

WHEREAS, the Agreement with Dokken Engineering will provide services including pre-design tasks, coordination with internal and external agencies, preparation of design plans and environmental studies, bidding, and construction support; and

WHEREAS, the Project includes replacement of approximately 7,126 linear feet of 6, 8, and 12 inch existing asbestos cement water mains, including all associated water services, fire hydrants, valves, and other appurtenances, construction of approximately 300 linear feet of new water main, and abandonment of approximately 1,072 linear feet of water mains; and

WHEREAS, the Project will also replace approximately 8,310 linear feet of existing 6, 8, 10, 12, and 15 inch vitrified clay and concrete sewer mains, including associated laterals, manholes, cleanouts, and other appurtenances, construction of approximately 1,111 linear feet of

new 8 and 10 inch sewer mains, rehabilitate approximately 550 linear feet of existing 8 inch vitrified clay sewer mains, and abandon approximately 907 linear feet of sewer mains; and

WHEREAS, under San Diego Charter section 99, no contract, agreement, or obligation extending for a period of more than five years may be authorized except by ordinance approved by a two-thirds majority vote of the City Council; and

WHEREAS, the Office of the City Attorney has drafted this ordinance based on the information provided by City staff, with the understanding that this information is complete, true, and accurate; NOW, THEREFORE,

BE IT ORDAINED, by the Council of the City of San Diego, as follows:

Section 1. That the agreement with Dokken Engineering for the purpose of providing consultant design services in CIP A-JA.00001, Sewer Main Replacements (B-21046, Golden Hill Improv 1 [S]); and in CIP A-KB.00003, Water Main Replacements (B-21047, Golden Hills Improv 1 [W]), for a term of seven years, in an amount not to exceed \$1,998,962.00, which is included in the staff materials accompanying this ordinance, and that once signed, will be on file in the Office of the City Clerk as Document No. OO- 21873 (Agreement), is approved.


Section 2. That the Mayor or his designee is authorized to sign and deliver the Agreement.

Section 3. That The Chief Financial Officer is authorized to expend an amount not to exceed \$1,998,962.00, of which \$1,117,838.25 is from CIP A-JA.00001, Sewer Main Replacements (B-21046, Golden Hill Improv 1 [S]), Fund 700008, Muni Sewer CIP; and \$881,123.75 is from CIP A-KB.00003, Water Main Replacements (B-21047, Golden Hills Improv 1 [W]), Fund 700010, Water Utility CIP for the purpose of executing this Agreement, contingent upon the adoption of the Annual Appropriations ordinance for the applicable fiscal year, and contingent upon the Chief Financial Officer first furnishing one or more certificates

certifying that funds necessary for expenditure are, or will be, on deposit with the City Treasurer;  
and

Section 4. That this ordinance shall take effect and be in force on the thirtieth day  
from and after its final passage.
