DATE OF FINAL PASSAGE OCT 18 2024

AN ORDINANCE OF THE COUNCIL OF THE CITY OF SAN DIEGO AUTHORIZING THE FIRST AMENDMENT TO THE AS-NEEDED ENVIRONMENTAL PLANNING SUPPORT SERVICES AGREEMENT WITH ICF JONES AND STOKES, INC. (H186996).

RECITALS

The Council of the City of San Diego (Council) adopts this Ordinance based on the following:

A. The City of San Diego (City) utilizes as-needed environmental planning support services agreements in support of its Capital Improvement Program (CIP) and other public projects.

B. On November 19, 2019, the City executed the As-Needed Environmental Planning Support Services Agreement (H186996) with ICF Jones and Stokes, Inc. (Agreement), to provide environmental planning support services for CIP projects.

C. Of the twenty-four tasks that were issued under the Agreement, eight tasks, AC Sewer and Water Group Job 850, College Area Sewer and Water, Storm Water Diversion at Point Loma Wastewater Treatment Plant, Beyer Park, El Capitan Dam Spillway and Slope Stability, Group Job 836, Lincoln Park Improvements 1 and Nestor Improvements 1 (collectively, Outstanding Tasks) are currently under design or construction and completion of these tasks will extend past the Agreement expiration date of November 18, 2024.

D. A First Amendment to the Agreement (First Amendment) will be necessary to extend the duration of the Agreement from 60 months to 96 months to complete the Outstanding Tasks.

E. Under San Diego Charter section 99, a supermajority vote of the Council is required for passage of this Ordinance.

F. The Office of the City Attorney prepared this Ordinance based on the information provided by City staff (including information provided by affected third parties and verified by City staff), with the understanding that this information is complete and accurate.

ACTION ITEMS

Based on the Recitals set forth above, the Council ordains as follows:

Section 1. The First Amendment to the Agreement with ICF Jones and Stokes, Inc. (H186996) to extend the Agreement duration from 60 months to 96 months, to complete the Outstanding Tasks, under the terms and conditions set forth in the First Amendment, which once signed will be on file in the Office of the City Clerk as Document No. OO- **21885**, is approved.


Section 2. The Mayor, or his designee, is authorized to sign and deliver the First Amendment to the Agreement.
