A RESOLUTION OF THE COUNCIL OF THE CITY OF
SAN DIEGO ADOPTING AN AMENDED VERSION OF
COUNCIL POLICY 900-01, TITLED “ECONOMIC
DEVELOPMENT.”

WHEREAS, effective June 19, 1975, the Council of the City of San Diego (Council) adopted San Diego Resolution R-213611 creating Council Policy 900-01, titled “Economic Development”; and

WHEREAS, since 1975, the Council has approved amendments to Council Policy 900-01 several times, including most recently in 2012; and

WHEREAS, Council Policy 900-01 provides the framework for the City of San Diego (City) to implement a comprehensive Economic Development Program and create a focused Economic Development Strategy (EDS) to guide the City’s economic development activities every three years; and

WHEREAS, in May 2023, the Council adopted the focused EDS for 2023-2026 (Current EDS), which prioritizes workers, families, inclusive economic growth, and equity; and

WHEREAS, the City’s Economic Development Department (EDD) is assessing and updating City programs and policies to bring them into alignment with the Current EDS; and

WHEREAS, EDD staff has prepared an amended version of Council Policy 900-01, identifying an updated list of economic development goals and activities consistent with the Current EDS; and

WHEREAS, on December 6, 2023, the Council’s Economic Development and Intergovernmental Relations Committee voted to recommend the Council’s approval of the

amended version of Council Policy 900-01, included in the docket materials accompanying this Resolution; and

WHEREAS, the Office of the City Attorney has drafted this Resolution based on the information provided by City staff, with the understanding that this information is complete, true, and accurate; NOW, THEREFORE,

BE IT RESOLVED, by the City Council of the City of San Diego, as follows:

1. The Council adopts the amended version of Council Policy 900-01, titled “Economic Development,” as set forth in Document No. RR- 315297 filed in the Office of the City Clerk.

2. The City Clerk is instructed to update the Council Policy Manual to include the amended version of Council Policy 900-01.
