A RESOLUTION OF THE COUNCIL OF THE CITY OF  
SAN DIEGO APPROVING THE SETTLEMENT BETWEEN  
SAMUEL ELLIS AND THE CITY OF SAN DIEGO

WHEREAS, on August 15, 2022, Samuel Ellis filed suit against the City of San Diego alleging personal injuries arising from an accident that occurred on September 11, 2021, as a result of a dangerous condition on Ocean View Boulevard. The suit is entitled *Samuel Ellis v. City of San Diego*, San Diego Superior Court Case No. 37-2022-00032566-CU-PO-CTL (Litigation); and


WHEREAS, in Closed Session on November 13, 2023, the City Council, by the following votes: Yeas, District(s) 1, 2, 4, 5, 6, 8, and 9; Nays, none; Absent, 3 and 7, approved settlement of the Litigation in the sum of \$275,000.00; NOW, THEREFORE,

BE IT RESOLVED, by the City Council of the City of San Diego, that the City Council:

1. Authorizes the Mayor or his designee to pay the sum of \$275,000.00 from the Public Liability Fund No. 720045, in settlement of each and every claim for damages, interest, costs, and fees of any type, against City of San Diego, its agents and employees, arising from the Litigation;

2. Authorizes the Chief Financial Officer to expend an amount not to exceed \$275,000.00 from the Public Liability Fund No. 720045, for the purpose of settling the Litigation.
