BROOKIE ROCHA AND THE CITY OF SAN DIEGO, ET, AL.

WHEREAS, on May 15, 2023, Brookie Rocha filed a suit against the City of San Diego and 15 police officers alleging injuries as a result of a failure to provide medical care following the use of pepper spray during a March 7, 2022 arrest. The lawsuit is entitled *Brookie Rocha v. City of San Diego, et al.*, United States District Court No. 23cv00885-CAB-JLB (Litigation); and


WHEREAS, in Closed Session on November 13, 2023, the San Diego City Council, by the following votes: Yeas, District 1, 2, 4, 5, 6, 8, and 9; Nays: None; Absent: Districts 3 and 7, approved the settlement of the Litigation for an amount consistent with the amount set forth below and pursuant to such other terms more fully set forth in the Settlement Agreement; and  
NOW, THEREFORE,

BE IT RESOLVED, by the City Council of the City of San Diego, that the Council:

I. Authorizes the Mayor or his designee to pay the sum of \$78,000.00 from the Public Liability Fund No. 720045, in settlement of each and every claim for damages, interest, costs, and fees of any type, against City of San Diego, its agents and employees, arising from the complaint filed by Brookie Rocha;

2. Authorizes the Chief Financial Officer to expend an amount not to exceed \$78,000.00 from the Public Liability Fund No. 720045, for the purpose of settling this claim.
