A RESOLUTION OF THE COUNCIL OF THE CITY OF
SAN DIEGO AMENDING APPOINTMENTS TO THE
SANDAG REGIONAL PLANNING COMMITTEE FOR
CALENDAR YEAR 2024.

WHEREAS, on December 13, 2023, the Council of the City of San Diego adopted San Diego Resolution R-315293 confirming appointments to various outside boards, commissions, committees, and government agencies, including appointments to the SANDAG Regional Planning Committee made by memorandum from Mayor Todd Gloria and Council President Sean Elo-Rivera; and


WHEREAS, SANDAG Board Policy No. 001, section 5.1, requires members of the SANDAG Regional Planning Committee to consist of SANDAG board members or their alternates; and

WHEREAS, the Mayor and Council President would like to appoint Council President Pro Tem Joe LaCava, as representative, and Councilmember Vivian Moreno, as alternate, to the SANDAG Regional Planning Committee, replacing Councilmember Stephen Whitburn, as representative, and Councilmember Kent Lee, as alternate; and

WHEREAS, the Office of the City Attorney has drafted this Resolution based on the information provided by City staff, with the understanding that this information is complete, true, and accurate; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, hereby confirms the appointment of Council President Pro Tem Joe LaCava, as representative, and Councilmember Vivian Moreno, as alternate, to the SANDAG Regional Planning Committee to serve through December 2024, and until a successor is duly appointed and confirmed.
