A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO AUTHORIZING THE ACCEPTANCE, APPROPRIATION, AND EXPENDITURE OF STATE COASTAL CONSERVANCY GRANT FUNDS FOR THE COASTAL RESILIENCE MASTER PLAN.

WHEREAS, the Legislature of the State of California has established the State Coastal Conservancy (Conservancy) under Division 21 of the California Public Resources Code and has authorized the Conservancy to award grants to public agencies and nonprofit organizations to implement the provisions of Division 21; and

WHEREAS, the Conservancy awards grants for projects that it determines are consistent with Division 21 of the Public Resources Code and with the Conservancy's Strategic Plan and that best achieve the Conservancy's statutory objectives, in light of limited funding; and

WHEREAS, the City of San Diego applied for Conservancy grant funding to support additional development and outreach for the City's Coastal Resilience Master Plan, which will identify specific resilience and conservation needs along San Diego's coastline, develop a portfolio of nature-based solutions, and support implementation of the Climate Resilient SD Plan (project); and

WHEREAS, on December 5, 2023, the Conservancy notified the City in writing that the grant application for the project was selected for funding in the amount of \$1,072,000; and

WHEREAS, the procedures established by the Conservancy require the grantee's governing body to certify by resolution the acceptance of the Conservancy grant funding and identification of the positions within the City authorized to negotiate and execute agreements related to the Conservancy grant; and

WHEREAS, the Office of the City Attorney has drafted this resolution based on the

information provided by City staff, including information provided by affected third parties and

verified by City staff, with the understanding that this information is complete, true, and

accurate; NOW, THEREFORE,

BE IT RESOLVED, by the City Council of the City of San Diego, that the Mayor, or his

designee, is authorized to take all necessary actions to secure funding for an amount not to

exceed \$1,072,000 in State Coastal Conservancy grant funds to support additional development

and outreach for the City's Coastal Resilience Master Plan, which will identify specific resilience

and conservation needs along San Diego's coastline, develop a portfolio of nature-based

solutions, and support implementation of the Climate Resilient SD Plan.

BE IT FURTHER RESOLVED, that the Chief Financial Officer is authorized to accept,

appropriate, and expend an amount not to exceed \$1,072,000 in State Coastal Conservancy grant

funds to support additional development and outreach for the City's Coastal Resilience Master

Plan, if the grant funding is secured, contingent upon receipt of a fully executed grant agreement.

BE IT FURTHER RESOLVED, that the Chief Financial Officer is authorized to establish

a special interest-bearing account for the grant funds, if necessary.
