WHEREAS, in Closed Session on October 30, 2023, the City Council, by the following votes:

Yeas, District(s) 1, 2, 3, 4, 5, 6, 8, and 9; Nays, District(s) None; and absent, District(s) 7, approved the Settlement Agreement; and

WHEREAS, the City Council in closed session on October 30, 2023 authorized settlement of the Litigation for an amount consistent with the amounts set forth below and pursuant to such other terms more fully set forth in the Settlement Agreement; NOW, THEREFORE,

BE IT RESOLVED, by the City Council of the City of San Diego, that the Council:

1. Authorizes the Mayor or his designee to pay the sum of \$250,000 from Public Liability Fund No. 720045 in settlement of each and every claim for damages, interest, costs, and

- fees of any type, including attorney fees, against City of San Diego, its agents, employees and contractors arising from the Litigation
- 2. Authorizes the Department of Finance to expend an amount not to exceed \$250,000 from Public Liability Fund No. 720045 for the purposes of settling this claim.
