A RESOLUTION OF THE COUNCIL OF THE CITY OF
SAN DIEGO CONFIRMING APPOINTMENTS AND A
REAPPOINTMENT TO THE MISSION BAY PARK
COMMITTEE.

WHEREAS, the Mission Bay Park Committee (Committee) is established in San Diego Municipal Code section 26.30(g) (Municipal Code) to serve in an advisory capacity to the Parks and Recreation Board, Mayor, Council of the City of San Diego (Council), and City Manager on policy issues relating to the acquisition, development, maintenance, and operation of Mission Bay Park; and

WHEREAS, the Committee also serves as the Mission Bay Park Improvement Fund Oversight Committee, as described in San Diego Charter section 55.2; and

WHEREAS, the Municipal Code provides that the Committee shall consist of 11 members appointed by the Mayor and confirmed by the Council; and

WHEREAS, the members shall serve two-year staggered terms so that no more than six members have terms expiring in any one year, and shall serve until a successor is duly appointed and qualified; and

WHEREAS, the Municipal Code provides that each member of the Committee shall possess expertise, or demonstrated experience or knowledge, in one or more of the following areas: auditing, finance or municipal finance, general business, planning, biology or environmental science, resource management or protection, wildlife management or protection, construction management, recreation management, or planning; and

WHEREAS, the Municipal Code also provides that the Committee shall include three members from nominations submitted by the Councilmember representing the Council

District that contains the largest geographic area of Mission Bay Park, which is currently Council District 2; three members from nominations submitted by the Councilmember representing the Council District that contains the next largest area of Mission Bay Park, or if none, the Council District located in closest proximity to Mission Bay Park, which is currently Council District 1; three at-large members; one Mission Bay lessee who shall represent a hotel in Mission Bay Park; and one Mission Bay lessee who shall represent a lessee in Mission Bay Park other than a hotel; and


WHEREAS, the Office of the City Attorney has drafted this resolution based on the information provided by City of San Diego (City) staff, including information provided by affected third parties and verified by City staff, with the understanding that this information is complete, true, and accurate; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, that the following appointments and reappointment by the Mayor of the City of San Diego, to serve as members of the Mission Bay Park Committee, for the terms ending as indicated, are made and hereby confirmed:
