A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO AUTHORIZING THE MAYOR AND CHIEF FINANCIAL OFFICER TO ACCEPT, APPROPRIATE, AND EXPEND \$1,474,719 IN GRANT FUNDING FROM THE CALIFORNIA BOARD OF STATE AND COMMUNITY CORRECTIONS TO PREVENT AND DECREASE MARIJUANA USE IN YOUTH THROUGH EDUCATION AND MENTORING PROGRAMS.

WHEREAS, in November 2016, voters approved Proposition 64, the Control, Regulate and Tax the Adult Use of Marijuana Act (Prop. 64); and

WHEREAS, Prop. 64 requires that a portion of the tax revenue from the cultivation and retail sale of cannabis will be appropriated to local law enforcement agencies to address public health and safety concerns associated with marijuana; and

WHEREAS, grant funds are not eligible to local governments who ban both indoor and outdoor commercial cannabis cultivation or retail sale pursuant to California Business and Professions Code section 26200; and

WHEREAS, the City does not ban indoor or outdoor commercial cannabis cultivation or retail sale and is therefore eligible for Prop. 64 funds; and

WHEREAS, the San Diego Police Department (Department) was awarded \$1,474,179 authorized by the California Board of State and Community Corrections (BSCC) in Prop. 64 grant funds to prevent and decrease marijuana use among youth through education and mentoring programs (Grant Programs); and

WHEREAS, Sports Training, Academics, and Recreation/Police Athletic League (STAR/PAL) is a not-for-profit organization whose mission is to build dialogues, cultivate

communal trust and lay the groundwork for an ethical community policing model to be applied nationwide; and

WHEREAS, Department employees work with STAR/PAL to forge mentorships, friendships, and lifelong support networks; and

WHEREAS, the Department will use this grant money to fund four STAR/PAL positions that will increase mentorship programs as well as to provide marijuana prevention and education to parents and families; and

WHEREAS, STAR/PAL will partner with the San Diego Association of Governments (SANDAG) Criminal Justice Research Division as the outside evaluator on this project; and

WHEREAS, SANDAG will provide invaluable insight into developing survey tools and gathering meaningful data metrics and outcomes on all programs, and ensure that programs are implemented effectively and reduce marijuana use among youth; and

WHEREAS, the Office of the City Attorney has drafted this resolution based on the information provided by City staff with the understanding that this information is complete, true, and accurate; NOW, THEREFORE,

BE IT RESOLVED, by the City Council of the City of San Diego, that Mayor, or his designee, is authorized, for and on behalf of the City, to accept \$1,474,719 in funding authorized by the BSCC, including any amendments, extensions, or renewals for a period of up to five years from Fiscal Year 2024 through and including Fiscal Year 2028, provided funding is secured and made available by the BSCC, for the purpose of implementing the Grant Programs.

BE IT FURTHER RESOLVED, that the Chief Financial Officer or his designee, is authorized to accept, appropriate and expend \$1,474,719 and any additional in funding authorized by the BSCC, for a period of up to five years from Fiscal Year 2024 through and including Fiscal Year 2028, for the purpose of implementing the Grant Programs.
