A RESOLUTION OF THE COUNCIL OF THE CITY OF
SAN DIEGO APPROVING THE SETTLEMENT BETWEEN
ESTHER SAMADI, ET AL. AND THE CITY OF SAN DIEGO,
ET AL.

WHEREAS, on April 19, 2021, Esther Samadi filed a lawsuit against the City of San Diego (City) alleging wrongful death of her husband, a bicyclist who collided with a City vehicle parked in the bicycle lane on September 25, 2020, on Carmel Valley Road. The suit is entitled *Esther Samadi, et al. v. City of San Diego, et al.*, San Diego Superior Court No. 37-2021-00018915-CU-PA-CTL (Litigation); and


WHEREAS, in Closed Session on January 8, 2024, the City Council, by the following votes: Yeas, Districts 1, 2, 3, 5, 6, 7, 8 and 9; Nays, None; and Vacant, District 4, approved the settlement of the Litigation for an amount consistent with the amounts set forth; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, that the Council:

1. Authorizes the Mayor or his designee to pay the sum of \$2,950,000.00 from Public Liability Fund No. 720045 in settlement of each and every claim for damages, interest, costs and fees of any type, including attorney fees, against the City, its agents and employees, arising from the Litigation.

2. Authorizes the Chief Financial Officer to expend an amount not to exceed \$2,950,000.00 from Public Liability Fund No. 720045, for the purpose of settling this Litigation.
