A RESOLUTION OF THE COUNCIL OF THE CITY OF
SAN DIEGO APPROVING THE SETTLEMENT BETWEEN
REYNA SANCHEZ AND THE CITY OF SAN DIEGO.

WHEREAS, on October 19, 2021, Reyna Sanchez filed a lawsuit against the City of San Diego (City) alleging personal injuries from a trip and fall accident on the sidewalk near 5111 La Cuenta Drive in the City of San Diego that occurred on June 5, 2020. The suit is entitled *Reyna Sanchez v. City of San Diego*, San Diego Superior Court Case No. 37-2021-00035596-CU-PO-CTL (Litigation); and

WHEREAS, in Closed Session on December 4, 2023, the City Council, by the following votes: Yeas, Districts 1, 2, 3, 4, 5, 6, 7, 8, 9; Nays, None; and absent, None, approved the settlement of the Litigation for an amount consistent with the amounts set forth; NOW, THEREFORE,


BE IT RESOLVED, by the Council of the City of San Diego that the Council authorizes:

1. Authorizes the Mayor or his designee to pay the sum of \$125,000.00 from Public Liability Fund No. 720045 in settlement of each and every claim for damages, interest, costs and fees of any type, including attorney fees, against the City, its agents and employees, arising from the Litigation.

2. Authorizes the Chief Financial Officer to expend an amount not to exceed \$125,000.00 from Public Liability Fund No. 720045, for the purpose of settling this Litigation.
