A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO TO APPROVE CITYWIDE PARK DEVELOPMENT IMPACT FEE ALLOCATIONS OF APPROXIMATELY \$16.2 MILLION TO 19 PARK IMPROVEMENT PROJECTS.

WHEREAS, on August 13, 2021, the Council of the City of San Diego approved Resolution R-313687 adopting the San Diego Parks Master Plan and Resolution R-313688 adopting a new Citywide Park Development Impact Fee, which was amended by Resolution R-314603 and Resolution R-315041; and

WHEREAS, as of November 8, 2023, there is approximately \$15.9 million available in the Citywide Park Development Impact Fee fund; and

WHEREAS, in addition to the approximately \$15.9 million Development Impact Fee (DIF) balance, the City has access to approximately \$363,000 in community-based DIF funds in Golden Hill, Mid-City, La Jolla, Encanto, Otay Mesa/Nestor, Southeastern, and Ocean Beach that are being allocated to park projects as a part of this action; and

WHEREAS, the Parks and Recreation Department wishes to transfer and expend a total of approximately \$16.2 million of DIF allocations (between Citywide and community-based) toward 19 park improvement projects; and

WHEREAS, the Office of the City Attorney has drafted this resolution based on the information provided by City staff, with the understanding that this information is complete, true, and accurate; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego that the following Capital Improvement Program (CIP) fund transfers, as detailed in the Staff Report attached as backup material to this Resolution, are approved, and the Chief Financial Officer is authorized to increase the CIP budgets as indicated, and is authorized to appropriate and expend the CIP funds as follows:
