A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO AUTHORIZING THE ACCEPTANCE, APPROPRIATION, AND EXPENDITURE OF \$3,666,572 FROM ROUND 2 OF THE STATE OF CALIFORNIA ENCAMPMENT RESOLUTION FUNDING PROGRAM ROLLING GRANT.

WHEREAS, on December 1, 2022, Governor Gavin Newsom of the State of California announced the Notice of Availability of Funding for \$240 million from Round 2 of the Encampment Resolution Funding Program rolling grant to close encampments and move people experiencing homelessness into housing and shelter; and

WHEREAS, in 2023, the County of San Diego (County) partnered with the City of San Diego (City), City of Santee, and California Department of Transportation to apply for a project focused on addressing encampments in the San Diego Riverbed corridor; and

WHEREAS, on June 14, 2023, the State of California Business, Consumer Services and Housing Agency's California Interagency Council on Homelessness notified the County of the award of Round 2 of the Encampment Resolution Funding Program rolling (ERF-2-R) grant in the amount of \$16,951,298; and

WHEREAS, on June 27, 2023, the County Board of Supervisors (Board) authorized the acceptance of ERF-2-R grant in the amount of \$16,951,298; and

WHEREAS, the Board authorized the County Chief Administrative Officer, or designee, to execute a subrecipient agreement with the City in the amount of \$3,666,572; and

WHEREAS, the funding being provided to the City under ERF-2-R grant will serve individuals experiencing homelessness in the San Diego Riverbed corridor in the City; and

WHEREAS, on February 5, 2024, the City's Grant Review Team approved the Homelessness Strategies and Solutions Department's application for the ERF-2-R grant; and

WHEREAS, the Office of the City Attorney has drafted this resolution based on the information provided by City staff, with the understanding that this information is complete, true, and accurate; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, that the Chief Financial Officer is authorized to accept, appropriate, and expend ERF-2-R grant funds in an amount not to exceed \$3,666,572, contingent upon the receipt of a fully executed grant agreement.

BE IT FURTHER RESOLVED, that the Mayor, or designee, is authorized to enter into a subrecipient grant agreement with the County in an amount not to exceed \$3,666,572 to fund ERF-2-R grant activities in the San Diego Riverbed corridor.

BE IT FURTHER RESOLVED, that the Mayor, or designee, is authorized to take all necessary action to administer, monitor, manage, and ensure compliance with the subrecipient grant agreement, and further to negotiate, enter into, and execute contracts with third parties to implement the subrecipient grant agreement or use of grant funds.

BE IT FURTHER RESOLVED, that the Chief Financial Officer is authorized to establish a special interest-bearing account for the ERF-2-R grant funds, if required, the proceeds of which will be used for any eligible uses outlined in the subrecipient grant agreement.
