A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO DECLARING THE RESULTS OF THE MUNICIPAL PRIMARY ELECTION, MUNICIPAL SPECIAL ELECTION, AND MUNICIPAL SPECIAL ELECTION TO FILL THE VACANCY IN COUNCIL DISTRICT FOUR HELD IN THE CITY OF SAN DIEGO ON MARCH 5, 2024.

WHEREAS, a Municipal Primary Election was held in the City of San Diego on Tuesday, March 5, 2024, under the provisions of San Diego Ordinance O-21742 (Oct. 31, 2023), to elect candidates to the offices of San Diego Councilmember for Districts 1, 3, 4, 5, 7, and 9, respectively; and

WHEREAS, a Municipal Special Election was held in the City of San Diego on Tuesday, March 5, 2024, under the provisions of San Diego Ordinance No. O-21743 (Oct. 31, 2023), to submit to the qualified voters of the City of San Diego one ballot measure, described as follows:

(1) One measure regarding whether to amend the San Diego City Charter by amending Article V, section 40 related to the elected City Attorney and adding section 40.2 related to legal counsel for the Office of the City Auditor and Audit Committee; and

WHEREAS, the measure, as stated in the ordinance placing them on the ballot, are:

MEASURE A CHARTER AMENDMENT AUTHORIZING THE CITY AUDITOR AND AUDIT COMMITTEE TO USE OUTSIDE LEGAL COUNSEL INSTEAD OF THE ELECTED CITY ATTORNEY. Shall Charter section 40 be	YES	
amended, and section 40.2 be added to authorize the City Auditor and Audit Committee to use outside legal counsel instead of the elected City Attorney, subject to certain conditions, when the Audit Committee determines such use is in the public interest?	NO	

WHEREAS, a Municipal Special Election was held in the City of San Diego on Tuesday, March 5, 2024, under the provisions of San Diego Ordinance No. O-21749 (Nov. 14, 2023), to elect candidates to fill the vacancy in Council District 4; and

WHEREAS, San Diego Charter section 10 directs that for elective offices, the two candidates receiving the highest number of votes in the Municipal Primary Election are to be declared as such, and then will advance to the Municipal General Election for the office; and

WHEREAS, under San Diego Municipal Code section 27.0108(c), if only one candidate qualified for the ballot in the Municipal Primary Election for a particular office, the sole qualified candidate receiving votes in that election shall be deemed to be, and declared by the Council of the City of San Diego (Council) to be, elected to such office after the results are certified. For those candidates, under San Diego Municipal Code section 27.0116, the term of office shall commence in December 2024; and

WHEREAS, under Charter section 302, for a special election to fill a vacancy, if one candidate receives the majority of votes cast for all candidates in the special election, the candidate receiving the majority of votes cast shall be deemed to be and declared by the Council to be elected to the vacant office. The person elected to fill the vacancy shall serve in that elective office for the remainder of the unexpired term; and

WHEREAS, the City Clerk has received from the County of San Diego Registrar of Voters a copy of the certificate canvassing the returns of the Municipal Primary Election, the Municipal Special Election, and the Municipal Special Election to fill the vacancy in Council District 4; and

WHEREAS, a canvass of these elections has been completed and the City Clerk has certified the results to the Council of the City of San Diego; and

WHEREAS, the Office of the City Attorney has drafted this resolution based on the information provided by City staff, including information provided by affected third parties and verified by City staff, with the understanding that this information is complete, true, and accurate; and

WHEREAS, declaring the results of these elections, as certified by the County of San Diego Registrar of Voters and the City Clerk, is a ministerial act required by California Elections Code section 10263 and, therefore, is not subject to veto by the Mayor; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, that the Council finds and determines, pursuant to the provisions of San Diego Municipal Code section 27.0411, as follows:

- 1. The City of San Diego had 797,330 registered voters eligible to vote in the March 5, 2024, Municipal Primary Election, Municipal Special Election, and Municipal Special Election to fill the vacancy in Council District 4. The total number of votes cast in the City for various district races ranged from a low of 15,407 to a high of 45,865 votes, for a total of 284,152 votes.
- 2. The total vote received by each municipal candidate at the Municipal Primary Election and the Municipal Special Election to fill the vacancy in Council District 4 is as follows:

A. FOR MAYOR (four-year term)

Todd Gloria and Larry Turner are hereby declared to be the two candidates receiving the highest number of votes and will advance to the Municipal General Election for the office of Mayor.

B. FOR CITY ATTORNEY (four-year term)

HEATHER FERBERT 122,894 VOTES (53.16%)

BRIAN MAIENSCHEIN 108,264 VOTES (46.84%)

Total 231,158 VOTES (100%)

Heather Ferbert and Brian Maienschein are hereby declared to be the two candidates receiving the highest number of votes and will advance to the Municipal General Election for the office of City Attorney.

C. FOR COUNCIL DISTRICT 1 (four-year term)

JOE LACAVA 24,283 VOTES (100%)

Joe LaCava, having been the only candidate qualified for the ballot in the Municipal Primary Election for the office of Councilmember for Council District No. 1, and as the sole qualified candidate receiving votes in that election, is hereby declared under San Diego Municipal Code section 27.0108(c) to be elected to the office of Councilmember, District No. 1. The term of this office will commence in December 2024.

D. FOR COUNCIL DISTRICT 3 (four-year term)

The term of this office will commence in December 2024.

The term of this office will commence in December 2024.
