A RESOLUTION OF THE COUNCIL OF THE CITY OF  
SAN DIEGO AUTHORIZING A COOPERATIVE  
PROCUREMENT CONTRACT WITH MANSFIELD OIL  
COMPANY OF GAINESVILLE, INC. FOR FUEL AND FUEL-  
RELATED SERVICES.

WHEREAS, the City of San Diego (City) has identified a need for the supply and delivery of fuel and fuel-related services throughout the City to service the needs of its fleet of vehicles; and

WHEREAS, the City's Department of General Services – Fleet Operations Division (FOD) oversees the City's fleet by providing comprehensive fleet management services to City departments including repair, maintenance, acquisition, replacement, disposition, and fuel for all motive equipment; and

WHEREAS, the City competitively bid out the contracts for the supply and delivery of fuel and fuel-related services, as recently as 2018 and entered into a contract which is set to expire; and

WHEREAS, on October 27, 2022, Sourcewell, formerly known as National Joint Powers Alliance (NJPA), issued a competitive solicitation for fuel delivery with related services resulting in an award to Mansfield Oil Company of Gainesville, Inc. (Mansfield) that is made available for other agencies to be used as a cooperative agreement; and

WHEREAS, the City is now seeking authorization to enter into a cooperative procurement contract with Mansfield (Contract) to procure its own fuel and fuel-related services

throughout the City, for a term extending through February 10, 2025, with up to three (3) additional one (1) year option extensions, and in an amount not to exceed \$88,000,000; and

WHEREAS, on January 9, 2024, the City's Purchasing Agent certified in writing that Sourcewell Contract No. 121522-MNF for Fuel Delivery with Related Services met the requirements for the use of cooperative procurement contracts set forth in San Diego Municipal Code section 22.3208; and

WHEREAS, the Office of the City Attorney has drafted this resolution based on the information provided by City staff, with the understanding that this information is complete, true, and accurate; NOW, THEREFORE,


BE IT RESOLVED, by the City Council of the City of San Diego, as follows:

1. That the Mayor, or his designee, is authorized to execute a Cooperative Procurement Contract with Mansfield Oil, for the as-needed supply and delivery of fuel and fuel-related services, in the amount not to exceed \$88,000,000 for a term extending through February 10, 2025, with up to three (3) additional one (1) year option extensions under the terms and conditions set forth in the Contract on file in the Office of the City Clerk as Document Number RR- 315459; and,

2. That the Chief Financial Officer is authorized to expend an amount not-to-exceed \$88,000,000 over the term of the Contract which includes up to three (3) additional one (1) year option extensions, for the supply and delivery of fuel and fuel-related services, contingent upon

adoption of the Annual Appropriation Ordinance for the applicable fiscal year, and contingent upon the Chief Financial Officer furnishing one or more certificates certifying that funds necessary for expenditure are, or will be, on deposit with the City Treasurer.
