A RESOLUTION OF THE COUNCIL OF THE CITY OF  
SAN DIEGO TO ENTER INTO A THIRD AMENDMENT TO  
THE SERVICE AGREEMENT WITH INVICTA SECURITY CA  
CORPORATION DBA ALLSTATE SECURITY.

WHEREAS, the City put forth a Request for Proposals (RFP, 10089334-18-M) to furnish the City with Citywide security services in August of 2018, resulting in a contract based on pertinent City sites with Allstate Security Services, Inc. approved by R-2019-589 (Agreement); and

WHEREAS, the Agreement has had two previous amendments to refine the scope of work and to increase expenditure including R-2023-434; and

WHEREAS, on or about July 31, 2021, Allstate Security Services Inc. effectively assigned its rights under the Agreement to Invicta Security CA Corporation; and

WHEREAS, several City departments including the Library department, Parks and Recreation department, Development Services Department, Department of General Services, and the San Diego Police Department continue to use the services provided under this contract; and

WHEREAS, the City seeks a resolution to authorize the Mayor or his designee to execute a Third Amendment to the Agreement to increase the expenditure authority from \$28,910,721 to \$32,910,721 over the term of the Agreement in order to serve the increased needs of the City; and

WHEREAS, the Office of the City Attorney has drafted this resolution based on the information provided by City staff, with the understanding that this information is complete, true, and accurate; NOW, THEREFORE,


BE IT RESOLVED, by the City Council of the City of San Diego, as follows:

1. That the Mayor or his designee is authorized to execute, for and on behalf of the City, the Third Amendment to the Citywide Security Service Agreement with Invicta Security CA Corporation, to increase the expenditure authority from \$28,910,721 to \$32,910,721 and to otherwise modify the Agreement pursuant to the terms and conditions contained in the Third Amendment to the Agreement on file with the City Clerk as Document No. RR-315464;

and

2. That the Chief Financial Officer is authorized to appropriate and expend an amount not to exceed \$32,910,721 over the full term of the Agreement, as amended, contingent upon the adoption of the Annual Appropriation Ordinance for the applicable fiscal year and contingent upon the Chief Financial Officer first furnishing one or more certificates certifying that funds necessary for expenditure are, or will be, on deposit with the City Treasury.
