A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO APPROVING A SIDE LETTER AGREEMENT BETWEEN THE CITY AND SAN DIEGO MUNICIPAL EMPLOYEES ASSOCIATION TO AMEND ARTICLE 21 OF THE MEMORANDUM OF UNDERSTANDING RELATED TO AN EQUITY ADJUSTMENT FOR THE STORES OPERATIONS SUPERVISOR CLASSIFICATION IN THE PURCHASING AND CONTRACTING DEPARTMENT.

WHEREAS, by San Diego Resolution R-314970 (June 12, 2023), the San Diego City Council approved a Memorandum of Understanding (MOU) between the City of San Diego and San Diego Municipal Employees Association (MEA) that establishes terms and conditions of employment for MEA-represented employees; and

WHEREAS, the Purchasing and Contracting Department (Department) is implementing a centralized inventory model to shift to shift management responsibilities to Central Stores' control. As such, staff needs to have higher level responsibilities which include a greater understanding of the procure to pay (P2P) process and additional responsibilities of analysis for the P2P process; and

WHEREAS, two vacant Account Clerk classifications were reclassified as two Administrative Aide II classifications to address the operational needs for this centralized inventory model; and

WHEREAS, the Stores Operations Supervisor classification will now supervise the higher-level Administrative Aide II classifications; and

WHEREAS, the City and MEA reached a tentative agreement to amend Article 21 of the MOU and provide an 18% equity adjustment for the Stores Operations Supervisor classification effective January 1, 2025 to address compaction and supervisory differential issues; and

WHEREAS, the terms of the tentative agreement are provided in the Side Letter Agreement (Agreement) on file in the Office of the City Clerk as Document No. RR- 315581 and


WHEREAS, the Agreement must be approved by a two-thirds majority vote of the Council to take effect, in accordance with San Diego Charter section 11.2; and

WHEREAS, the Office of the City Attorney has drafted this resolution based on the information provided by City staff, with the understanding that this information is complete, true, and accurate; NOW, THEREFORE,

BE IT RESOLVED, by the City Council of the City of San Diego, that the Council approves the Agreement between the City and MEA to amend Article 21 of the MOU to provide an .18% equity adjustment for the Stores Operations Supervisor classification in the Purchasing and Contracting Department effective January 1, 2025, which is on file in the Office of the City Clerk as Document No. RR- 315581 .
