WHEREAS, the Program will enhance recruitment, retention, and diversity of the City's more than 12,000 employees; and

WHEREAS, the grant will strengthen San Diego's capacity to address our most important needs including climate change, education, public service, housing, food insecurity, and expanding opportunities for San Diegans of all backgrounds; and

WHEREAS, the Office of the City Attorney has drafted this resolution based on the information provided by City staff, including information provided by affected third parties and verified by City staff, with the understanding that this information is complete, true, and accurate; NOW, THEREFORE,

BE IT RESOLVED, by the City Council of the City of San Diego, that the Human

Resources Department is authorized to accept, secure funding, appropriate, and expend

Californians For All grant funds in an amount not to exceed \$7,590,985 over a 15-month period,

and the Chief Financial Officer is authorized to establish a special interest-bearing account for

the grant to fund the City's Employ and Empower Youth Workforce Program.
