BONNY CARNEY AND CITY OF SAN DIEGO.

WHEREAS, on July 9, 2020, Plaintiff Bonny Carney filed a lawsuit against the City of San Diego, alleging personal injuries arising from a trip and fall accident that occurred on September 21, 2019. The suit is entitled *Bonny Carney v. City of San Diego, et al.*, San Diego Superior Court Case No. 37-2020-00023766-CU-PO-CTL (Litigation); and


WHEREAS, in Closed Session on May 13, 2024, the City Council, by the following votes: Yeas, Districts 1, 2, 3, 4, 5, 6, 7, 8, and 9; Nays, none; Absent, none, approved the settlement of the Litigation for an amount consistent with the amounts set forth below and under such other terms more fully set forth in the Settlement Agreement; and NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, that the Council:

1. Authorizes the Mayor or his designee to pay the sum of \$125,000 from Public Liability Fund No. 720045, in settlement of each and every claim for damages, interest, costs, and fees of any type, including attorney fees, against the City of San Diego, its agents, employees and contractors arising from the Litigation.

2. Authorizes the Chief Financial Officer to expend an amount not to exceed \$125,000 from Public Liability Fund No. 720045, for the purpose of settling this Litigation.
