A RESOLUTION OF THE COUNCIL OF THE CITY OF
SAN DIEGO APPROVING THE SETTLEMENT BETWEEN
RENE ANDRADE AND THE CITY OF SAN DIEGO.

WHEREAS, on February 8, 2021, Rene Andrade (Plaintiff) filed a lawsuit against the City of San Diego (City) alleging damages arising from a trip and fall incident, entitled, *Rene Andrade v. City of San Diego*, San Diego Superior Court Case No. 37-2021-00005881-CU-PO-CTL (Litigation); and

WHEREAS, in closed session on May 13, 2024, the City Council, by the following votes: Yeas, Districts 1, 2, 3, 4, 5, 6, 7, 8, and 9; Nays, None; approved settlement for an amount consistent with the amount set forth below; and NOW, THEREFORE,

BE IT RESOLVED, by the City Council of the City of San Diego, that the Council:

1. Authorizes the Mayor or his designee to pay the sum of \$87,500.00 from the Public Liability Fund No. 720045, in settlement of each and every claim for damages, interest, costs, and fees of any type, including attorney fees, against the City, its agents and employees, arising from the Litigation;

2. Authorizes the Chief Financial Officer to expend an amount not to exceed \$87,500.00 from the Public Liability Fund No. 720045 for the purpose of settling this Litigation.
