A RESOLUTION OF THE COUNCIL OF THE CITY OF
SAN DIEGO CONFIRMING AN APPOINTMENT AND
REAPPOINTMENT TO THE COMMUNITY FOREST
ADVISORY BOARD.

WHEREAS the Community Forest Advisory Board (Board) is established in San Diego Municipal Code section 26.0501 through 26.0503 (Municipal Code) to advise the Mayor, Council of the City of San Diego (City Council), and City Manager on policy issues relating to urban forestry; and

WHEREAS, the Municipal Code provides that the Board consist of 15 members appointed by the Mayor and confirmed by the City Council; and

WHEREAS, the Mayor shall appoint one member who shall be designated Chair; and

WHEREAS, nine of the members shall be appointed from nominations submitted by each Councilmember to represent their district; and

WHEREAS, additionally, the Mayor shall appoint five members who shall be a landscape architect; a certified arborist/urban forester; a horticulturist/nursery industry representative; a representative from a non-profit organization or governmental agency involved with forestry; and an artist; and

WHEREAS, members serve three-year terms and each member serves until a successor is appointed and confirmed; and

WHEREAS, members shall be appointed so that the terms of not more than five members shall expire in any year; and


WHEREAS, the Office of the City Attorney has drafted this resolution based on the information provided by City staff, including information provided by affected third parties and

verified by City staff, with the understanding that this information is complete, true, and accurate; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, that the following appointment and reappointment by the Mayor, to serve as members of the Community Forest Advisory Board, for the terms ending as indicated, are made and hereby confirmed:
